

Anually more than 71,000 North Texas adults learn to live daily with the effects of stroke, traumatic brain injury, or brain cancer. **BIND: Brain Injury Network of Texas provides tools and a bridge of support to adult brain injury survivors so they can reconnect into life, the community and work-place.** BIND's vision is to lead the DFW area in providing member-driven services and serve as the model for Brain Injury Clubhouses across the state of Texas. We are celebrating our 10th anniversary in 2021!

BIND's services join the gap between medical rehabilitation and independent, contributing community living. At BIND, brain injury survivors are Members, not 'patients'. Through the Clubhouse Model BIND empowers members to maximize their strengths and provides a necessary link in the recovery process.

At the BIND Clubhouse the core of the model is an emphasis on person-centered programming – allowing each brain injury survivor to regain a sense of control by choosing how they interact with and engage in a work-ordered day. Members manage Clubhouse daily activities, gain work skills and address appropriate social behaviors. They also build physical /cognitive endurance through wellness activities and challenges, increase self-esteem, and develop skills necessary to live more independently. BIND's services and overall goals are to reduce the severity of depression, increase the return to gainful employment or productive community volunteering, and improve quality of life for those living with brain injury and their families.

In 2020 BIND adapted our Clubhouse and services in the face of the COVID-19 crisis. We continue to provide programs and engagement through our new virtual Clubhouse. Once we safely return to our physical location we will continue and build on virtual services to reach even more families.
